### EXTENSION OF THE BID SUBMISSION CLOSING DATE

The **Federal Democratic Republic of Ethiopia** has received financing from the African Development Fund which are administered by the African Development Bank hereinafter called the Bank toward the cost of the **Ethiopia Djibouti Second Power Interconnection Project**, and intends to apply part of the proceeds toward payments under the Contract for:-
  - ETDJ2PIP, **LOT-1A**: "-Design Supply and Installation of 230kV Double Circuit 102 km Transmission Line from Semera Substation to Galafi (Djibouti Border),



For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and Procedures for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.

2. The Ethiopian Electric Power now invites sealed Bids from eligible Bidders for **ETDJ2PIP, LOT-1A: "-Design Supply and Installation (DSI) of 230kV Double Circuit 102 km Transmission Line from Semera Substation to Galafi (Djibouti Border).**
3. Bidding will be conducted through the Open Competitive Bidding (International), OCBI procedures as specified in the Bank's [Procurement Framework](#) for Borrowers dated October, 2015, which can be found at the following website: [www.afdb.org](http://www.afdb.org), IFB and is open to all eligible Bidders as defined in the Procurement Framework.
4. Interested eligible Bidders may obtain further information from Ethiopian Electric Power and inspect the Bidding document during office hours 8:00 AM to 5:00 PM, local time (Addis Ababa) at the address given below.
5. The bidding document in English may be purchased by interested eligible Bidders up on submission of a written application to the address below and up on payment of a nonrefundable fee of Ethiopian Birr Nineteen Thousand only (ETB 19,000) or US\$ 150 (One Hundred Fifty) or its equivalent in a freely convertible currency from the Ethiopian Electric Power, Procurement office. The method of payment shall be in cash or cashier's check or through telegraphic transfer to EEP Transmission Construction A/C No.: 1000252665203, Commercial Bank of Ethiopia (CBE), Arada Giorgis Branch, Swift Code: CBETETAA; and EEP BUMBUNA HPP A/C No.0101181300051, National Bank of Ethiopia (NBE), Swift Code: NBETETAA, for ETB and Foreign Currency Account respectively starting from **24 February 2025 from 8:00 AM to 5:00 PM Local Time Addis Ababa**, at the address given below
6. Bids must be delivered to the address below on or before **30 April 2025** at 2:00pm. Electronic bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **30 April 2025** at 2:30pm.
7. All Bids must be accompanied by a Bid Security of **Lot-1A: 380,000 USD (three hundred eighty thousand US dollars)** or its equivalent in a freely convertible currency.
